FULL SELF-EXCLUSION FROM PARTICIPATION IN GAMBLING GAMES AND CANCELLATION OF A USER ACCOUNT

If you request full self-exclusion from participation in gambling games at any of our premises, you can only do so by filling an application containing an authenticated signature sent to the Ministry of Finance of the Czech Republic. Following the verification of your application, the Ministry will enter your record in the Register of Natural Persons Excluded from Participation in Gambling ("Register of Excluded Persons"). This record will be then binding upon all operators of games of chance in the Czech Republic. As the operator, we are not entitled to accept any other form of request for full self-exclusion, except for setting up your self-regulation measures. Information regarding the completion of the application for an entry in the Register of Excluded Persons is available at the casino reception desk.
